This document provides information regarding your personal data processed by the camera systems operated by Amagasaki Pipe Czech s.r.o., ID: 27115348, with registered office at Japonská 461, 331 44 Kožlany, registered at the Regional Court in Plzeň, Section C, Entry 16502 (hereinafter referred to as the "operator"). Purpose of Processing

The camera system with recording is used for the purpose of protecting individuals and property of the operator, making it necessary for the legitimate interests of the operator (Art. 6, par. 1, letter f), GDPR).

The camera system is used to monitor a designated area as a means of preventing and documenting certain facts and events in space and time for potential subsequent evidence. The recorded data category includes the appearance and actions of individuals within the monitored area.

The areas monitored by cameras are always marked with appropriate signs referring to this information before entering the monitored area.

From Whom We Obtain Personal Data and to Whom We Transfer It?

Personal data is obtained through cameras that automatically record all activity.

Personal data may be transferred to relevant authorities (especially law enforcement authorities for the purpose of protecting the property and interests of the operator or another person, or in cases provided for by law). Personal data is not transferred outside the EU.

How We Process Personal Data?

Personal data is processed automatically by camera systems, and the evaluation of recordings is manual. How Long We Process Personal Data?

Records are kept for 21 days. In the event of relevant findings, they may be processed for a longer period during the resolution of a potential incident and the processing of personal data to protect our rights or the rights of third parties. What Are Your Rights?

Personal data is not processed based on consent, so it cannot be deleted even if you request it. However, we will always review whether further processing is necessary.

You have the right to request access to your personal data, including obtaining a copy of all your personal data. We will always inform you about:

The purpose of processing personal data.

Personal data or categories of personal data being processed, including all available information about their source.

The nature of automated processing, including profiling, and information about the method used, as well as the significance and expected consequences of such processing for the data subject.

Recipients or categories of recipients.

The planned period for which personal data will be stored, or if it cannot be determined, the criteria used to determine this period.

All available information about the source of personal data if not obtained from you.

Your rights also include:

Requesting an explanation.

Requesting us to eliminate the situation, especially involving blocking, correction, completion, processing restriction, or deletion of personal data (right to be forgotten).

Requesting personal data concerning you in a structured, commonly used, and machine-readable format and transferring this data to another controller without hindrance.

Submitting a query or complaint to the Office for Personal Data Protection.

Objecting to the processing of personal data concerning you.

How We Protect Your Personal Data:

Personal data is always processed in accordance with relevant legal regulations, ensuring proper care and protection. We ensure that you do not suffer harm to your rights, especially the right to respect human dignity, and we protect you from unauthorized interference in your private and personal life. Camera recordings are secured by physical security measures, antivirus protection, firewalls, encryption, authorization data, etc.
